### DIRECTIONS FOR USE

Read entire label before using. Use only as directed. Be sure surfaces to be cleaned are swept or vacuumed to remove loose debris before cleaning. Always pretest surface with cleaning solution for suitability prior to cleaning. Wear protective eyewear, gloves, long sleeves, and long pants while handling concentrate. Ensure work area is well-ventilated during application and until surface is dry. Keep children and pets out of the area during application and drying.

1. For normal soiling, mix 16 ounces (1 pint) of solution with gallon of warm or hot water (1:8) into a professional spray applicator. Hydroforce Inline Injection Sprayer, pour one gallon of solution into sprayer bottle. Use normal 1 to 8 metering tip for application.
2. Apply mixed solution with sprayer (mask off sensitive surfaces) evenly and liberally across surface to be cleaned. If preferred, you can apply mixed solution with a damp mop, sponge, or other appropriate professional equipment.

3. Dilute Viper Neutral Stone Cleaner at 1 oz./gallon with hot water for portable units. Mix concentrate in a truckmount unit at one quart per 5 gallons of water. Meter as usual. For best results, agitate and extract cleaning solution using Viper Neutral Stone Cleaner and a rotary agitation surface tool such as a Hydroforce SX-12 or Hydroforce SX-7. On sensitive surfaces such as soft marble, make sure the floor has been thoroughly vacuumed or swept to remove pebbles, sand or other abrasive material prior to cleaning prior to using rotary agitation and extraction tool. For especially sensitive finishes, use the Hydroforce Gekko tool with brush head instead for extraction.

4. Rinse the area thoroughly and allow to dry. Accelerate drying with air mover like the OmniPro Omnidry making sure to leave no puddling in grout lines.

5. To protect stone surfaces from future stains and spills, consider application of Viper Prestige Water-based or Solvent-based Impregnating Sealers.
